

# 2013 Annual Report, Trans Pride Initiative

## *Statement from the President*

Trans Pride Initiative was founded in August 2011, and one full-time volunteer began working with the organization in the summer of 2012. In 2013, we for the most part continued our work begun during the latter half of 2012..

## *Our Mission*

Trans Pride Initiative empowers trans and gender nonconforming persons to rise above social barriers to equal healthcare, housing, employment, and education.

## *Our Work*

During FY 2013, as in the year previous, most of our work involved developing relationships and becoming involved in other programs to help spread awareness of the concerns and needs of the trans community. Much of this involved joining in the work of other organizations such as the Dallas City Counsel's LGBT Task Force and other local, state, and national LGBTQ advocacy organizations. We also began getting involved where we could with shelter operators to help improve access to shelters for trans persons. During 2012 and 2013, we estimate that we had nearly 3,000 interactions with persons through our participation in panels, presentations and community events.

TPI continued to operate the Trans Network Affiliates Program, which we hoped would encourage trans organizations and those with an interest in reducing discrimination and increasing access to services to come together in recognition of common goals. However, it did not grow to garner the response that we had hoped.

## *Our Accomplishments*

In 2013, we held our second annual health fair in conjunction with the University of Texas Southwestern Medical School's Center for Breast Care. We made an effort to expand the reach of the health fair through encouraging other UTSW departments to participate, but response was limited.

This year, we also began coordinating with Parkland Health and Hospital System to expand access to trans-affirming healthcare for low-income trans persons.

During this year, we helped at local shelter Austin Street Centre as they implemented a new vulnerable persons policy, and provided a major presentation with AIDS Arms to Dallas County Probation officers for the National Association of Blacks in Criminal Justice.

# *Financial Report*

Our revenue and expenses continued to be limited during the second full year of operation, with less than \$500 raised from individual contributions outside the organization, but we did see a tenfold increase in individual donations. This year, revenue generated by TPI was able to cover all operating expenses. The TPI fiscal year runs from January 1 to December 31.
